

U.S. Passport Checklist

Complete the DS-11 application using BLACK INK ONLY and free of marked correction errors

The next section requires black and white photocopies on 8 1/2" x 11" paper for each starred \bigstar :

- Proof of U.S. Citizenship: ★ (One of the following: must be original or certified copy & photo copied)
 - - □ Birth Certificate issued by vital records
 - □ Consular Report of Birth Abroad or Certification of Birth
 - □ Naturalization Certificate or Certificate of Citizenship
 - □ Previously issued, undamaged U.S. Passport
- □ Proof of Identity: ★ (One of the following must easily identify the applicant original & photo

- □ Valid Driver's License; if out-of-state, may need additional ID
- □ Previously issued, undamaged U.S. Passport
- □ Naturalization Certificate
- Current Military ID (military or dependents) or Government ID (city, state or federal)
- □ Applicants **ages 16 & 17:** A parent/legal guardian may present as primary ID if minor does not have acceptable ID
- **Passport photo:**
 - □ Official color photograph 2" x 2" taken within the past 6 months
 - □ Arrive 10 min. early for photos taken at Testing Center \$15 fee (credit, debit, check, or cash)
- **Pay Passport Fees:** Fees are paid separately at the time of application
 - □ Check or money order made payable to the U.S. Department of State, AND
 - □ Check, money order, debit or credit card made payable to **"WWU"** (for Execution fee of \$35) For further details, forms and current passport fees go to www.travel.state.gov

□ Applicants under age 16:★

- Applicants ages 15 and younger must have **both** parents/legal guardian(s) present
- □ Original or certified Birth Certificate must be presented for proof of parental relationship & copied
- □ If only one parent/legal guardian can appear, form DS-3053 must be submitted with application
- □ If one parent/guardian has sole custody, certified proof of sole legal custody must be submitted and photo copied
- □ Proof of Identity from each parent per application &(photo copy)

Applicants age 16 & 17: ★

- □ It is recommended that at least one parent appear in person with the applicant to show parental awareness
- □ Original or certified Birth Certificate & (photo copy)
- □ Proof of Identity from applicant Parent/legal guardian may present their Primary ID if minor applicant does not have one & (photo copy)
